CALL TO ORDER – ROLL CALL

Mayor, Rheta Reagan, called the regular meeting of the Edmonton Common Council to order at 7:00 P.M. on April 1, 2025, at Edmonton City Hall. Present were Council members David Levey, Jarrell Rola, Jason Shook, Dennis Tubb. Brent White was absent.
